### DEAR MEMBER OF PARLIAMENT,

We cordially invite you to join us in Helsinki on the 6th – 8th of October 2023 to participate in the 8th Open European Dialogue – Architects of the Future: European Policymaking in Times of Uncertainty, Technological Disruption and Societal Adaptation.

Being a politician today, in times of uncertainty and ambiguous futures, is a challenge which is felt across the continent and regardless of political colours.

Our Annual Policymakers Dialogue will bring together a select cohort of politicians from across Europe to explore today's policymaking challenges through the lens of technological advancements that are changing the world we live in.

Technological advancements have the potential to radically alter the playing field of policymaking due to their profound and often ambiguous societal, economic, ethical, and political implications.

Recent developments surrounding the use of generative artificial intelligence are but the latest example of the pace and depth of change with which politics is confronted.

Beyond the obvious influence on the way in which we consume and make use of information, technological advancements affect the way we think about environmental policy, the future of the labour market, issues of migration and mobility, as well as foreign policy - to name a few of the affected policy areas.

There is an evident tension between those who see technology as a solution to all of humanity's problems and those who see an urgent need to address the harm these technologies can bestow upon the well-being of individuals and societies. The divide grows deeper as a clear path on how to manage the regulation of emerging technologies is yet to be found.

- How can politicians be architects of our societies' futures while standing on ever-shifting grounds?
- How can policymakers handle the emergence of a new global competition among actors with different approaches towards the use of technology in society?
- How can policymakers prepare for the emergence of new societal disparities and ruptures?
- How can politicians regulate emerging technologies in the absence of an in-depth understanding of their opportunities and risks? Who will be involved in the shaping of new regulation?

#### A Brave New World?

New technologies are changing the way we live and work with each other and may require new models for policymaking.

Our dialogue will take place against the backdrop of a European political agenda that has been championing a twin transition by linking technological and green investments. National and European policymakers are being called upon to build a regulatory architecture that encourages innovation while leaving no one behind.

This policy window reveals radically novel opportunities for politicians to have a profound impact on the way we design our future societies.

The dialogue will begin on Friday, the 6th of October (17:00 EEST) and end on Sunday, the 8th of October (16:30 EEST).



The Open European Dialogue is a politically neutral platform that aims to improve European politics by supporting policymakers in better understanding challenges and perspectives from across Europe. We do that by connecting European politicians across parties and countries, providing space for dialogue, and promoting innovative political conversations in ways that no one else does.

The network serves as a platform for the over 12,000 national parliamentarians of the EU and beyond. Its active network comprises over 180 members from 36 European countries, representing around 70 different political parties.

Our members convene regularly for dialogues, conference calls, fact-finding missions, expert workshops, and other activities.

Since 2017, the network also empowers parliamentarians to develop their own cooperative, cross-party and cross-country spin-off initiatives. Our policy experts from four internationally renowned think tanks offer input to ensure the highest quality of dialogue.
